Educational Service Provider (ESP) Amendment Form

Per Charter Contract 4.0 Article III and XI, an Educational Service Provider (ESP) is defined as a non-profit or for-profit entity that is contracted by the School to provide services that would otherwise be handled by employees of the School, which include, but are not limited to, operational back office functions and services related to the instructional design or operation of the School, in return for fees.

A school must request to amend its charter contract if it is proposing to remove or enter into an agreement/contract with an ESP. These changes need to be approved by the Commission and memorialized in an executed charter contract amendment. The ESP agreement shall be subject to, and shall incorporate by reference, the terms and conditions of the Charter Contract. The term of the ESP agreement shall not exceed the term of the Charter Contract.

***Please note that new ESPs must be approved by the Commission prior to the start of the target school year. The Commission will not consider proposed amendments to a school's ESP during the year prior to or during the year of a high-stakes review and/or renewal.
