College Prep Focus, Inquiry-based curriculum, Global Citizenship / Character Education, Coding / Robotics. In designing our academic program, we studied the most successful public charter schools nationwide, which are known for rigorous college preparatory academic programs, high college acceptance, and high academic achievement. We have reviewed the curriculum, content, skills, and knowledge expected of students attending these schools so we can deliver the same high quality education. We integrated the best practices from three high-performing charter college prep models on the mainland, who serve similar underserved student populations with great success. Minority low-income students do not only need rigorous academics but also necessary support and tracking systems. Our program provide a comprehensive approach with college mentorship and data-driven instruction through MAP Testing, Illuminate's DnA system and grade level teacher's bi-weekly meetings to analyze individual students' progress towards assigned goals.
