

**FIRST AMENDMENT TO THE HAWAI'I ACADEMY OF ARTS AND SCIENCE PUBLIC CHARTER SCHOOL JULY 1, 2023 PUBLIC CHARTER SCHOOL CONTRACT**

This FIRST Amendment to the July 1, 2023 Charter Contract (the "Amendment") is entered into and made effective as of the date last signed below (the "Effective Date"), by and between the **STATE PUBLIC CHARTER SCHOOL COMMISSION** located at 1164 Bishop Street, Suite 1100, Honolulu, Hawaii, 96813 (the "Commission"), and **HAWAI'I ACADEMY OF ARTS AND SCIENCE PUBLIC CHARTER SCHOOL**, whose mailing address is P.O. Box 1494, Pahoia, HI 96778, (the "School"), (collectively the "Parties").

**I. Recital**

**WHEREAS**, at the January 11, 2023 General Business Meeting, the Commission approved the Charter Contract (version 4.0) with the School for a five-year term effective as of July 1, 2023 through June 30, 2028;

**WHEREAS**, on December 5, 2025, the School requested a First Amendment to the Charter Contract to Amend Section 2.1 Charter to remove 15-1839 32nd Avenue, Kea'au, HI 96749 ("Aloha Academy") as a Brick and Mortar Instructional, Blended Learning Program and Virtual Learning Non-Instructional Site and to amend the grades served at the Brick and Mortar Instructional, Blended Learning Program and Virtual Learning Non-Instructional Sites;

**WHEREAS**, on February 23, 2026, the Commission unanimously passed a Motion to approve the School's request to Amend the Charter Contract Section 2.1 Charter; and

**NOW, THEREFORE**, in consideration of the foregoing Recital and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as set forth below:

**II. Amendment**

This First Amendment amends Section 2.1 Charter of the Charter Contract as set forth below.
