

THIRD AMENDMENT TO THE HAWAI'I TECHNOLOGY ACADEMY JULY 1, 2023 PUBLIC CHARTER SCHOOL CONTRACT

This THIRD Amendment to the July 1, 2023 Public Charter School Contract (the "Amendment") is entered into and made effective as of the date last signed below (the "Effective Date"), by and between the **STATE PUBLIC CHARTER SCHOOL COMMISSION** located at 1164 Bishop Street, Suite 1100, Honolulu, Hawai'i, 96813 (the "Commission"), and **HAWAI'I TECHNOLOGY ACADEMY** ("School"), whose mailing address is 94-450 Mokuola Street, #200, Waipahu, HI 96797, (the "School"), (collectively the "Parties").

I. Recital

WHEREAS, at the January 12, 2023 General Business Meeting, the Commission approved the Charter Contract (version 4.0) with the School for a five-year term effective as of July 1, 2023 through June 30, 2028; and

WHEREAS, the Charter Contract identified blended learning instructional sites on the O'ahu, Hawai'i Island, Maui, and Kaua'i;

WHEREAS, on September 8, 2023, the School requested a First Amendment to the Charter Contract to Amend Section 2.1 Charter to add 4975 Lower Honoapi'ilani Road, Lāhainā, HI 96761 ("Door of Faith Campus") as an additional blended learning instructional site;

WHEREAS, on October 16, 2023, the Commission unanimously passed a Motion to approve the School's requested amendment;

WHEREAS, on February 12, 2024, the School requested a Second Amendment to the Charter Contract to Amend Section 2.1 Charter to replace a blended learning instructional site from the Door of Faith Campus with 200 Kapalua Drive, Lāhainā, HI 96761 ("Kapalua Resort Site");

WHEREAS, on March 14, 2024, the Commission through a majority vote passed a Motion to approve the School's request;

WHEREAS, on September 2, 2025, the School requested a Third Amendment to the Charter Contract to Amend Section 2.1 Charter to remove a blended learning instructional site located at 77-6425 Kuakini Hwy., Kailua-Kona, Hawai'i, 96740 on the Hawai'i Island; and

WHEREAS, on October 9, 2025, the Commission unanimously passed a Motion to approve the School's requested amendment.

NOW, THEREFORE, in consideration of the foregoing Recital and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as set forth below:

II. Amendment

This Third Amendment amends the following section as they appear on the Charter Contract:

Section 2.1 Charter is amended by removing the School's Instructional Site located at:

77-6425 Kuakini Hwy., Kailua-Kona, Hawai'i, 96740

III. No Other Effect

The Third Amendment, along with original Charter Contract, and all prior Amendments, forms the entire agreement between the Parties. Except as otherwise expressly provided in this Third Amendment, all of the terms or conditions of the Charter Contract and prior Amendments remain unchanged and in full force and effect.


