

SECOND AMENDMENT TO THE KONA PACIFIC PUBLIC CHARTER SCHOOL JULY 1, 2021 PUBLIC CHARTER SCHOOL CONTRACT

This SECOND Amendment to the July 1, 2021 Charter Contract (the “Amendment”) is entered into and made effective as of the date last signed below (the “Effective Date”), by and between the **STATE PUBLIC CHARTER SCHOOL COMMISSION** located at 1164 Bishop Street, Suite 1100, Honolulu, Hawaii, 96813 (the “Commission”), and **KONA PACIFIC PUBLIC CHARTER SCHOOL**, whose mailing address is P.O. BOX 729, Kealakekua, Hawai‘i 96750, (the “School”), (collectively the “Parties”).

I. Recital

WHEREAS, at the January 10, 2020 General Business Meeting, the Commission approved the Charter Contract (version 4.0) with the School for a five-year term effective as of July 1, 2021 through June 30, 2026;

WHEREAS, on November 28, 2022, the School requested a First Amendment to the Charter Contract to Amend Section 2.2 Mission Statement;

WHEREAS, on March 9, 2023, the Commission unanimously passed a Motion to approve the School’s request to Amend the Charter Contract Section 2.2 Mission Statement;

WHEREAS, on July 20, 2025, the School requested a Second Amendment to the Charter Contract to Amend Section 2.1 Charter to add a non-instructional location at 79-1020 Haukapila Street, Kealakekua, HI 96750; and

WHEREAS, on October 9, 2025, the Commission unanimously passed a Motion to approve the School’s request to Amend the Charter Contract Section 2.1.

NOW, THEREFORE, in consideration of the foregoing Recital and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as set forth below:

II. Amendment

This Second Amendment amends the following section as they appear on the Charter Contract:

Section 2.1 Charter is amended by adding the School’s Non-Instructional Site with:

79-1020 Haukapila Street, Kealakekua, Hawai‘i 96750
The Non-Instructional Site is used for administrative use-only.

III. No Other Effect

This Second Amendment, along with the original Charter Contract and prior Amendment, forms the entire agreement between the Parties. Except as otherwise expressly provided in this Second Amendment, all of the terms or conditions of the Charter Contract and prior Amendment remain unchanged and in full force and effect.
