# AMENDMENTS TO THE NĀ WAI OLA PUBLIC CHARTER SCHOOL JULY 1, 2021 PUBLIC CHARTER SCHOOL CONTRACT

## I. Background

The following Amendments to the July 1, 2021 Public Charter School Contract (the "Amendments") effective as of June 20, 2022, March 9, 2023 and July 01, 2023, respectively (the "Effective Dates"), are by and between the **STATE PUBLIC CHARTER SCHOOL COMMISSION** located at 1164 Bishop Street, Suite 1100, Honolulu, Hawaii, 96813 (the "Commission"), and **NĀ WAI OLA PUBLIC CHARTER SCHOOL** ("School"), whose mailing address is P.O. BOX 711539, MOUNTAIN VIEW, HAWAI'I, 96771, (the "School"), (collectively the "Parties").

**WHEREAS**, at the June 10, 2021, 2020 General Business Meeting, the Commission approved the Charter Contract (version 4.0) with Nā Wai Ola Public Charter School for a five-year term effective as of July 01, 2021 through June 30, 2026;

**WHEREAS**, on May 17, 2022, Nā Wai Ola Public Charter School requested to amend the Charter Contract to remove St. Theresa Parish, 18-1355 Volcano Highway, Mountain View, Hawai'i 96771 as a learning facility and the School's grade 6 (six) program due to lack of facilities for the 2022-2023 school year;

**WHEREAS**, on June 20, 2022, the Commission unanimously passed a Motion to approve the School's request to amend the Charter Contract to remove St. Theresa Parish as a learning facility as well as grade 6 (six) to allow facility changes; and

**WHEREAS**, on January 25, 2023, Nā Wai Ola Public Charter School requested to amend the Charter Contract Section 2.2 Mission Statement; and

**WHEREAS**, on March 9, 2023, the Commission unanimously passed a Motion to approve the School's request to amend the Charter Contract Section 2.2 Mission Statement; and **WHEREAS**, on April 26, 2023, Nā Wai Ola Public Charter School requested to amend the Charter Contract to add grade 6 (six); and

**WHEREAS**, on May 25, 2023, the Commission unanimously passed a Motion to approve the School's request to amend the Charter Contract to add grade 6 (six) in SY 23-24, grade 7 (seven) in SY 24-25, and grade 8 (eight) in SY 25-26, effective July 1, 2023; and

**WHEREAS**, the parties agree to amend the July 01, 2021 Public Charter School Contract and to the following changes set forth in this Amendments, it is hereby understood and agreed as follows,

### II. Amendments

The amendment to remove grade 6 (six) and St. Theresa Parish, 18-1355 Volcano Highway, Mountain View, Hawai'i 96771 as a learning facility, effective June 20, 2022, and the subsequent amendment to add grade 6 (six) through 8 (eight), effective July 1, 2023 are agreed to by the parties to modify the July 01, 2021 Public Charter School Contract, in the corresponding section referenced below:

#### Section 2.1 Charter

The School shall establish a public charter school in the State of Hawai'i on the island(s) listed in the table below. The School operates their Educational Program in the manner and at the facilities located at the address(es) indicated in the table below along with the grades served in accordance with this Charter Contract, the Hawai'i Revised Statutes, and other applicable federal, state, and county laws, ordinances, codes, rules and regulations. Enrollment in the School shall be open to all students of ages and grades as set forth in HRS Chapter 302D and Article IX of this Charter Contract, who are residents of the State of Hawai'i. This Charter Contract shall constitute the School's charter and shall be binding on the School, the Governing Board, and the Commission.
